



**General Challenge Rules:** A minimum ½ yard of "challenge fabric" must be purchased at Creative Threads by March 20. A recognizable amount of the "challenge fabric" must be used as an integral part of the entry, and must appear in the body of the quilt, not just the border. No more than 1 one yard of the "challenge fabric" may be used in the entire entry, but any amount of any other fabric may be used. Fabric is limited and will be sold on a first come, first serve basis. There will be two categories for submission: (1) Quilts; and (2) Bags/Purses/Garments. Entries must be received at Creative Threads (Greene location) no later than April 20, 2010. Submissions will be displayed at Creative Threads (Greene location) from April 21-May 19, 2010. Judging to be conducted by public vote during this time.

**Quilt Category Entry Rules:** The quilt can be any shape, but the combined total of all sides of the quilt cannot be less than 160 inches (for example a 40" x 40" quilt equals 160"). All quilts must be secured with quilting or tying – false backs not secured to the batting or quilt front may not be used.

**Bags/Purses/Garments Category Entry Rules:** Garment submissions may be of any size.

**Voting Rules:** One vote per category per person per visit to Creative Threads (Greene location).

**Submission Requirements:** Each submission that is entered into the Contest must meet ALL of the "Submission Requirements" set forth (any Submission that, in Creative Threads' good faith judgment, violates the following criteria will be disqualified): The Submission must be the submitting entrant's own work. The Submission must not include images or text that is obscene, pornographic, libelous, illegal, discriminative or otherwise objectionable; and the Submission must not include any corporate logos or any other material that may infringe on any third parties copyrights or trademarks. By entering into this Contest, each entrant represents and warrants that his or her Submission is entrant's own, that such Submission does not violate the rights of any third party or infringe or violate any law, and as of the date of the Submission, and if a pattern was used or adapted that credit is given to the book, pattern, instructor, or other source that inspired your submission. Limit one entry per category per person.

**Posting of Submissions Online:** All Submissions may be photographed and posted in a virtual gallery on the Creative Threads' website or on Facebook.com along with entrant's name. By participating in the Contest, each entrant irrevocably grants Creative Threads the rights to use such entrant's name, likeness and Submission(s) in any and all media for any purpose, including without limitation advertising and promotional purposes, as well as, the Contest and/or other promotions conducted by Creative Threads, and each entrant hereby releases the Sponsor from any liability with respect thereto.

**Winner Selection:** At the end of the Voting Period (April 21-May 19, 2010), Creative Threads will review the votes and select one (1) Grand Prize winner and (1) First Place winner in each category. The winner will be announced on May 20, 2010 by Creative Threads (Greene location), whose decisions will be final and binding in all matters related to this Contest.

**Prizes:** (1) Grand Prize of a sewing machine with approximate retail value \$199. (1) First Place Prize for "Quilts Category" of \$50 Creative Threads Gift Certificate. (1) First Place Prize for "Bags, Purses, and Garments Category" of \$50 Creative Threads Gift Certificate.

**Claiming Prize:** Winners will be notified by phone then by email within 10 days of the selection. All prizes will be awarded. One prize per person.

**Winners' List:** Will be posted on Creative Threads' website and Facebook.com within 10 days of the selection.
